1. Consider recommendations to the Town Council regarding an ordinance amending the Town of Bartonville Code of Ordinances, Chapter 14, Exhibit "A," Article 14.02, Ordinance 361-05, Zoning regulations, by amending, Chapter 11.A, Article 11.A.2 Uses Permitted, for the Town of Bartonville, by granting a Conditional Use Permit to allow for the operation of an Agricultural Store located at 2201 E FM 407, Bartonville, Texas. The property to be considered for the Conditional Use Permit is zoned Rural Services District (RS). Agricultural Store is a permitted use by Conditional Use Permit only in the Rural Services District. **(The public hearing was held and Commission action on recommendations was postponed at the November 7, 2018 meeting)**
2. Discuss and consider recommendations to the Town Council regarding an application for a Site Plan for a Tractor Supply (Agricultural Store) located on a 5.41-acre lot at 2201 E FM 407, Bartonville, Texas on the northwest corner of E FM 407 & Hilltop Road. The applicant is also seeking approval for a flat roof and outdoor storage.
