-84.8% (\$580,708) of the budgeted property taxes have been collected for the fiscal year. The Town receives almost all payments in the months of December, January, and February.

-The budget amendment to the Fiscal Year 2017-18 budget was approved at the January 16th Council meeting. Per the amendment, \$20,000 was transferred to the Reserve Fund (150) and \$25,780 was transferred to the Street Maintenance Fund (170).

-Annual disbursements to employee Health Savings Accounts were made in the amount of \$2,125 per full time employee and are reflected in line items 100-10-2025 and 100-20-2025.



Revenue Reports







Franchise Fee Revenue General Fund FY 2017-2018



