I am happy to announce the appointment of the Town's new Administrator, Thad Chambers. Thad most recently served as Economic Development Director for the City of Haslet, has more than 15 years of municipal service and considerable experience working with Councils, Boards, and Commissions. Residents are invited to a Meet and Greet with Thad on July 19th at 5:30 p.m., prior to the Regular Town Council Meeting at Bartonville Town Hall.

I would also like to extend a special thanks to Cori Reaume who served as our interim for eight months and assisted with the recruitment process. We truly appreciate her time and efforts in keeping our operations running and your assistance with the Town Administrator search. Thank you.

It is time again to trim tree limbs impacting safety on our roadways. The most common concerns are limbs obscuring street signs (Speed Limit, Stop Sign, Curve Ahead) or impeding visibility/sight lines near intersections. In some areas limbs also overhang the roadway and can be broken by delivery trucks and create a hazard when they fall into the roadway. The Town Council has directed staff to seek bids to address these concerns and we will be communicating with all affected property owners as we move forward to improve safety.

Due to an increase of requests from citizens regarding neighborhood traffic concerns the Town Council will be creating an ad hoc committee to review and make recommendations to Town Council on local transportation issues such as cut-through traffic and speeding vehicles. Although Fireworks are permitted in Bartonville, please be mindful of your neighbors. Loud noises from fireworks can trigger PTSD in military veterans, disturb horses, pets, and many dogs go missing. New Bartonville Businesses:

The Barrel, a new neighborhood wine and whisky bar, opened in the former Grapes to Wine space located in Bartonville Town Center. Their menu focuses on high-quality food, bourbon, and wine.

Dutch Bros Coffee, located in Lantana Town Center, serves handcrafted specialty coffee, smoothies, freezes, teas, and energy drinks. Opening is scheduled for June 24th.

Marty B's Coffee Co., located next to Marty Bs, is scheduled to open mid-July featuring their own brand of coffee, smoothies, pastries, brisket breakfast tacos, coffee cocktails and more.

Trio's Italian Grille is opening soon to the former Palermo's space located in Bartonville Town Center. Construction is underway.

New Subdivisions Under Construction:

Trifecta Estates – This RE-2 subdivision includes 8 residential lots on just over 20 acres. With infrastructure nearing completion, new home permit applications are anticipated in the next 30 days.

Hudson Ranch – This RE-2 subdivision includes 33 residential lots on approximately 85 acres. A Letter of Substantial Completion was issued for the infrastructure improvements the week of June 23rd.

Eagle Ridge – This RE-2 subdivision includes 38 residential lots on 87 acres. Infrastructure improvements are anticipated to continue for several months in this subdivision.
